

# Housing Market Indicators

## Monthly Update



### January 2022

U.S. Department of Housing and Urban Development

National housing market indicators available as of January showed activity in housing markets was mixed overall. Trends in some of the top indicators for this month include:

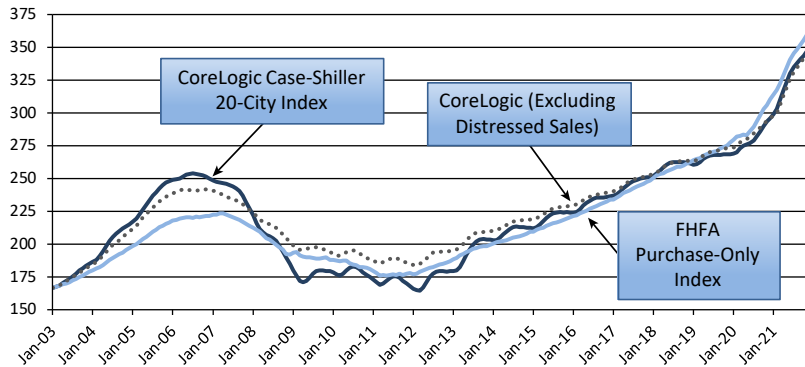
- **Purchases of new homes rose.** New single-family home sales increased 11.9 percent to 811,000 units (SAAR) in December from a downwardly revised pace of 725,000 units in November but were 14.0 percent lower than one year ago. Monthly data on new home sales tend to be volatile. New home sales are based on a purchase agreement. The preliminary estimate of new home sales for all of 2021 is 762,000 units, 7.3 percent lower than in 2020 (822,000 units). (Sources: HUD and Census Bureau)
- **Sales of existing homes declined after increasing for three straight months.** The National Association of Realtors® (NAR) reported that December sales of existing homes (including single-family homes, townhomes, condominiums, and cooperatives) fell 4.6 percent to 6.18 million units (SAAR) from an upwardly revised pace of 6.48 million in November and were 7.1 percent below a year earlier. Sales were down in all four Census regions. Because existing home sales are based on a closing, December sales reflect contract signings in October and November. Interest rates are low, but lean inventories and house price growth are constraining sales. For all of 2021, existing home sales, at 6.12 million units, were 8.5 percent higher than in 2020 and the strongest pace since 2006.
- **New home construction increased.** Total housing starts rose slightly (1.4 percent) to 1.70 million units (SAAR) in December and were up 2.5 percent from one year ago. Single-family housing starts declined 2.3 percent to 1.17 million homes (SAAR) in December from an upwardly revised pace of 1.20 million the previous month and were 10.9 percent lower than a year earlier. Multifamily housing starts (5+ units in a structure), at 524,000 units (SAAR), increased 13.7 percent from 461,000 units in November and were 56.0 percent higher than last year. Month-to-month changes in the construction of multifamily homes are often volatile. Construction material costs and labor shortages continue to constrain homebuilding. For all of 2021, total construction of new homes reached 1.595 million units, 15.6 percent higher than in 2020 (1.380 million units) and the strongest pace since 2006. New construction of single-family and multifamily homes increased 13.4 and 22.1 percent, respectively, for all of 2021 compared with the previous year. (Sources: HUD and Census Bureau)
- **Year-over-year house price increases remained high in November, with annual gains ranging from 17.5 to 18.3 percent.** The Federal Housing Finance Agency (FHFA) seasonally adjusted purchase-only house price index for November estimated that home values increased 1.12 percent from the previous month and 17.5 percent year-over-year, up marginally from a 17.4-percent annual gain in October. The FHFA index shows that U.S. home values are 61 percent above the peak set in April 2007 during the housing bubble. The non-seasonally adjusted (NSA) CoreLogic Case-Shiller® 20-City Home Price Index, posted a 0.99 percent increase in home values in November and year-over-year returns of 18.3 percent, down from an 18.5-percent annual gain in October, and the fourth straight month that annual price gains slowed following a thirteenth-month acceleration. The home price data for both indices are based on real estate sales contracts signed in late September and October with subsequent closings during November. (Both price indices are released with a 2-month lag.)
- **The inventory of homes for sale rose for new homes but reached a record low for existing homes.** The listed inventory of new homes for sale, at 403,000 units at the end of December increased 1.5 percent from November and was up 34.8 percent year-over-year. That inventory would support 6.0 months of sales at the current sales pace, down from 6.6 months in November due to the large gain in December sales. Available existing homes for sale reached a record low of 910,000 units in December, down 18.0 percent from November and 14.2 percent from 1.06 million units a year earlier. That listed inventory represents a 1.8-month supply, also a record low and down from 2.1 months in November. The long-term average for months' supply of homes on the market is 6.0 months.
- **Forbearance on mortgage loans continued to decline.** The MBA Forbearance Survey (now monthly) shows the share of homeowners with mortgages in forbearance was 1.41 percent (705,000 households) in December, down from 5.46 percent one year ago. The forbearance rate reached a high of 8.47 percent in June 2020 but was only 0.25 percent of all home loans in the beginning of March 2020, before the economic effects of the COVID pandemic began to be felt.
- **Housing insecurity due to the pandemic remains elevated.** HUD analysis of the [Census Household Pulse Survey](#) (Week 41; data collection: December 29, 2021 – January 10, 2022) shows that approximately 15.1 percent, or 6.77 million, renter households were behind on rental payments. On average, renter households were 2.35 months behind on their payments and 11.0 percent were 6 or more months behind. An estimated 12.5 percent of renter households were not at all confident in their ability to pay their rent on time, and 7.1 percent, or 3.17 million, renter households feared eviction was imminent in the next two months. Under Treasury's Emergency Rental Assistance (ERA) program, 2.61 million renters have applied for and received rental assistance. HUD estimates that 6.7 percent, or 5.30 million, homeowner households were behind on their mortgage payments. Approximately 3.5 percent of homeowner households were not at all confident in their ability to pay their mortgage on time, and 1.06 percent, or 840,000, homeowners feared foreclosure was imminent in the next two months.
- **The 30-year fixed-rate mortgage (FRM) remains above 3 percent.** The 30-year FRM reached an average weekly low in January of 3.22 percent the week ending January 6, up from a low in December of 3.05 percent the week ending December 23. The record weekly low interest rate is 2.65 percent the week ending January 7, 2021, which was one year prior to this month's low. (Source: Freddie Mac)

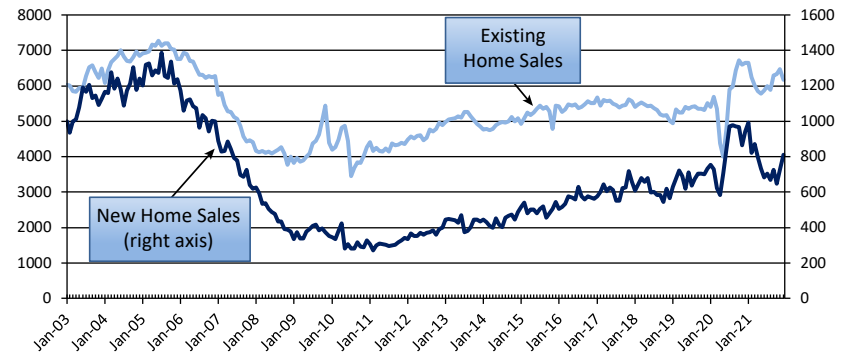
Monthly House Price Trends by Index (\$ Thousands)

### Sales Rose for New Homes But Fell for Existing Homes

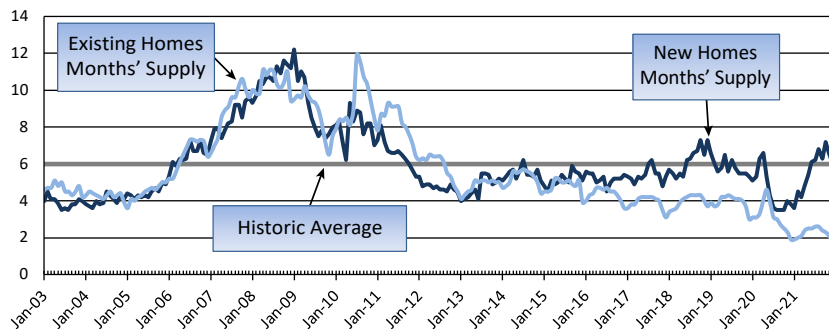
Monthly Sales (Thousands)

### The Months' Supply of Homes for Sale Fell for Both New and Existing Homes

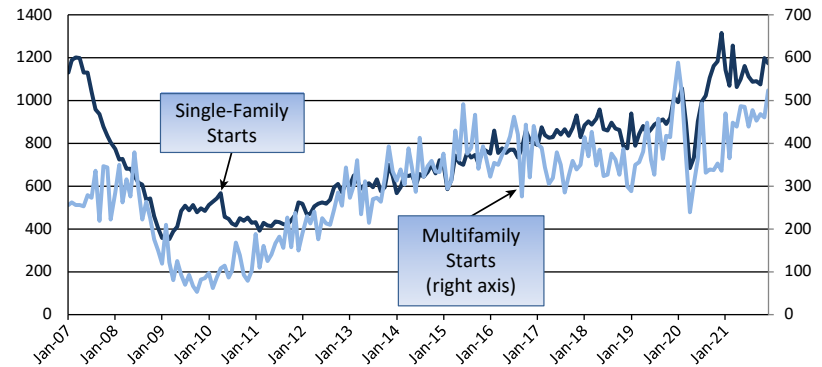
National Months' Supply of New and Existing Homes (Months)

National Housing Starts (Thousands)



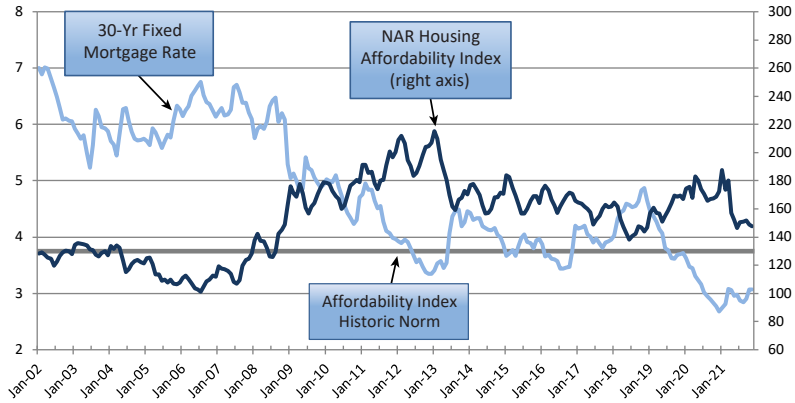

**Homeownership Affordability Remains Above Historic Norm, Mortgage Rates Near Record Lows**

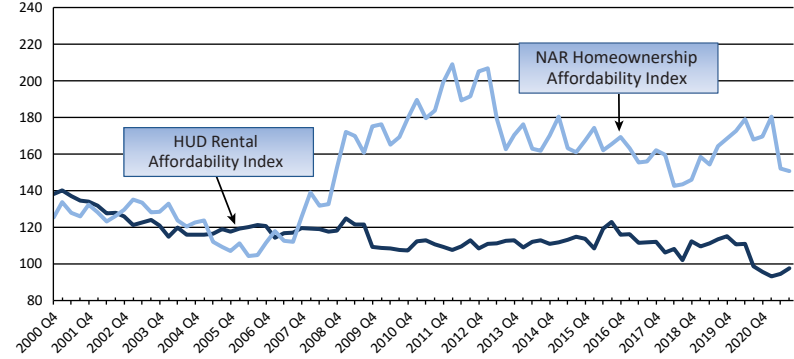
Percentage Rates and Index Values

**Rental Affordability Remains a Challenge Due to Rising Rents**

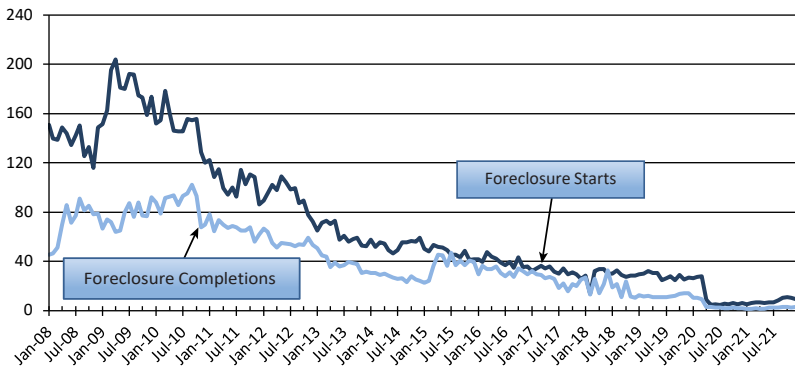
Rental and Homeownership Index Values

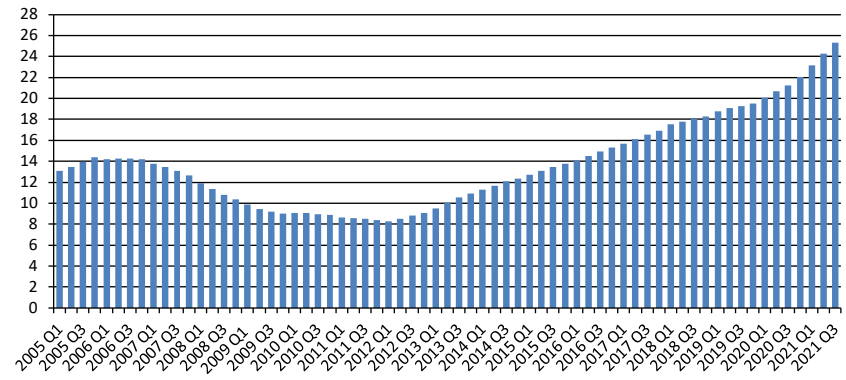
Monthly Foreclosure Actions (Thousands)

Owners' Equity in Household Real Estate at End of Period (\$ Trillions)



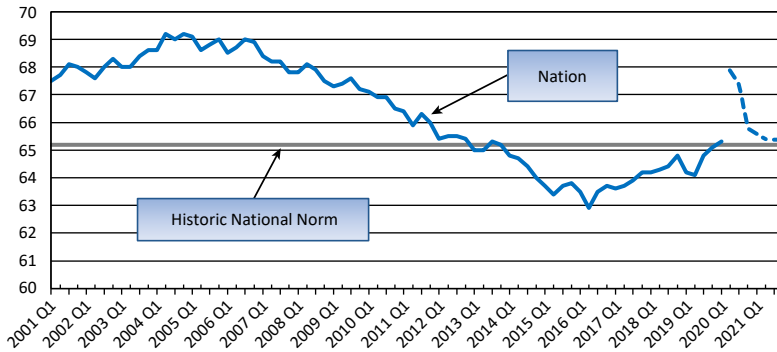

### The National Homeownership Rate Remained the Same in the Third Quarter\*

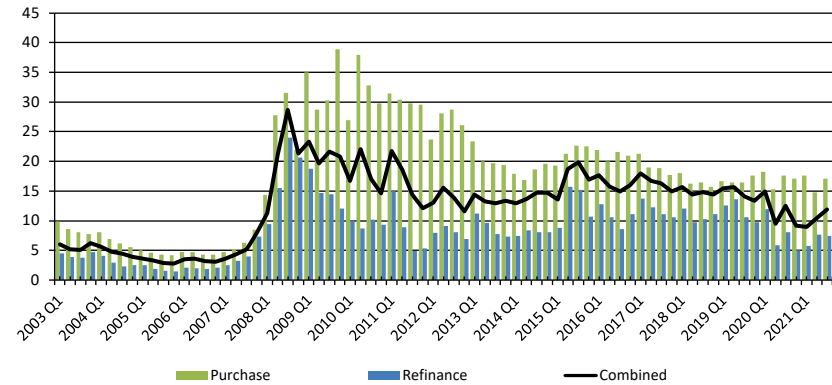
National Homeownership Rate (Percent)

### FHA Mortgage Lending

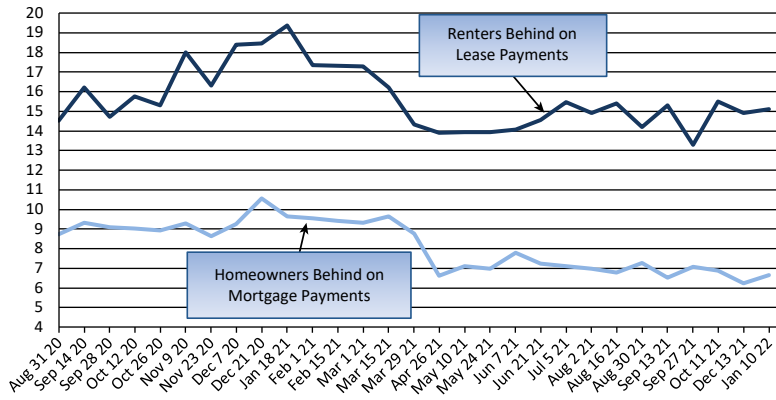
FHA as Share of Quarterly Mortgage Originations by Type (Percent)

### Housing Insecurity Due to the Pandemic

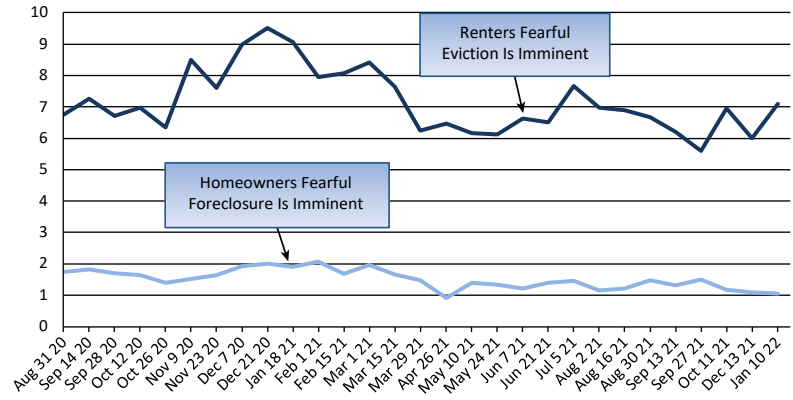
Share of Renter and Homeowner Households Behind on Housing Payments (Percent)

Indices shown: S&P/CoreLogic Case-Shiller 20-metro composite index (NSA), January 2000 = 100, FHFA monthly (purchase-only) index for U.S. (SA), January 1991 = 100, and CoreLogic-Distressed Sales Excluded (Monthly) for U.S. (NSA), January 2000 = 100. #### C. Additional Notes

Beginning in May 2019, NAR replaced its Composite Housing Affordability Index (HAI), which was based on the 30-year fixed rate mortgage and adjustable rate mortgages (ARM), with a Fixed HAI based only on the 30-year fixed rate mortgage.

Black Knight enhanced their database as of December 2017 data, increasing their database coverage by nearly 1 million additional loans through several new contributors and improved coverage of certain types of data. In addition, HUD added filters to make sure all FHA and VA loans were excluded from the data to ensure reporting of only conventional loans. The November 2017 changes in reported data are mainly due to the additional filters.

FHA Market Share data were updated in the June 2017 report based on the most recent HMDA data and revised house price estimates. FHA market share estimates were based on new methodology beginning with the October 2013 report; estimates were revised back through Q1 2011. The estimate for first-time buyers was 33 percent for 2019, based on the 2019 NAR annual survey of homebuyers released in October 2019. The estimate was the same as their estimate for 2018 with the October 2018 release of the NAR Profile of Home Buyers and Sellers 2018 report. The annual reporting of first-time buyers differs from NAR's monthly Realtors Confidence Index survey because the annual survey, for the most part, represents purchases of homes by owner-occupants and does not include purchases by investors, as in the monthly survey.

CoreLogic's House Price Index (HPI) estimates are based on new methodology beginning with their June 2016 report, which includes data through April 2016. A variety of modeling and other enhancements to their HPI and its forecast, including a 14-percent expansion in the number of transaction pairs, were made.

MBA switched to reporting monthly forbearance data in place of weekly data starting November 2021.

There was a 2-month gap in the collection of Census Household Pulse Survey data as it transferred to Phase 3.3 of the survey. Data for Week 40, the first survey of Phase 3.3, took place from December 1, 2021 to December 13, 2021 and was released on December 22, 2021. Data collection during Phase 3.3 will occur every other two weeks instead of every two weeks.

The BLS Consumer Population Survey/Housing Vacancy Survey (CPS/HVS) is conducted by the Census Bureau and collects data on indicators used in this report, including the homeownership rate, housing units held off market, and housing rental prices. The Bureau views the 2Q 2020 through 2Q 2021 period as a break in series because COVID-19 prevented normal data collection procedures. The Census Bureau suspended in-person interviews on March 20, 2020 and conducted the survey for the rest of the first quarter and the entirety of the second quarter solely by telephone interviews. In-person interviews were incrementally added back in the subsequent four quarters with respective rates of 63, 94, 98, and 99 percent of in-person interviews allowed. Normal data collection procedures resumed in Q3 2021 with less than one-half of one percent of in-person interviews restricted. Analysis of data provided by the Census Bureau on a subset of areas where 100 percent of in-person interviews were allowed in the 4th quarter of both 2019 and 2020 by the Harvard JCHS suggest the U.S. homeownership rate likely increased over the year from 4Q 2019 to 4Q 2020, but by less than the amount estimated using the full data set. The data subset shows the homeownership rate increased 0.4 percentage point over the four-quarter period compared to a 0.7 percentage point increase using the full data set. This implies the homeownership rate may have increased from 65.1 percent in 4Q 2019 to 65.5 percent in 4Q 2020. Results were not provided for housing units held off market and rental prices.
